HIGHLIGHTS					
Levying of service charges on cash withdrawal and cash handling (Deposit) under ABB w.e.f 09/06/2014					

- 1.0 Our bank has implemented Core Banking Solution in all of our branches. One of the features of the Core Banking solution is Any Branch Banking, wherein a customer can operate his account in any of the remote branch in addition to his home branch, where his account is maintained.
- 2.0 Under the ABB arrangement, the customer can draw and deposit cash from / to his home branch besides having the same facility available at remote branches also.
- 3.0 At present under ABB, no charge is levied by our Bank either for Cash Withdrawal or Cash Deposits for any type of accounts. The facility is totally free to the customers both at their home branch as well as at remote branches.
- 4.0 However, many Banks including Public Sector Banks are levying charges on Cash Withdrawal and Cash Handling (Deposit) for SB/CA/CC/OD accounts, based on the number of the transactions and / or volume of the transactions.
- 5.0 Considering the escalation in cost, following charges shall apply for ABB transactions w.e.f. 09.06.2014:-
