The Medical Fitness Certificate format is also attached with the hard copy of Provisional Offer of Appointment and the same is also available on Bank's website. The charges for medical check-up have to be borne by the candidates. Your final place of posting will be informed to you upon successful completion of pre-recruitment formalities and being found medically fit in the pre-recruitment medical examination.
