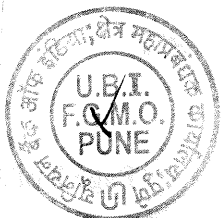

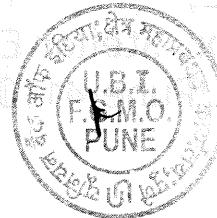

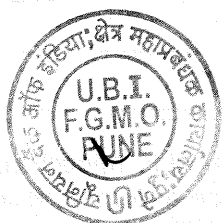

- 1.1.1. Furnishing work (including civil work new as well as repair/renovation of existing premises, structural rehabilitation of building, furniture, sanitary and plumbing, waterproofing etc.)
- 1.1.2. Electrical work including Repairs, Earthing, ATM grouting etc.
- 1.1.3. Air Conditioning (Installation, Servicing & Maintenance).
- 1.1.4. Architects & Structural Engineers.

1.2. Union Bank of India, Zonal Office Pune invites sealed application forms (Technical bids) from reputed vendors having not less than 5 years of experience of the work for which empanelment is sought in above mentioned categories for Branches, ATMs and offices of Union Bank of India under Regional Office Greater Pune and Regional Office Pune Metro. The bidders should fulfill all mandatory conditions/requirements mentioned in this tender document.

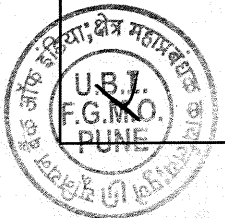
1.3. Pune Zone consists of all the Branches, ATMs and Admin offices of Union Bank of India spread over Districts viz. Pune, Satara, Raigad and herein after will be referred as Pune Zone. The geographical location may change as per requirement of bank.

1.4. Separate Application forms along with prescribed tender fee is to be submitted by the vendor for empanelment under each category. If the vendor submits more than one application in single bid or does not submit tender fee for each category, the bid will be summarily rejected. e.g. vendor applying for Electrical and Furnishing work has to submit two different applications in two separate envelopes with separate tender fee. The contractor should clearly mention the name of work for which empanelment is sought, on the envelope itself.

1.5. RFP Forms can be downloaded from bank's website www.unionbankofindia.co.in, eprocure.gov.in or can be collected from Zonal Office Pune on any working day during office hours and can be submitted along with the Technical bid and Tender cost of Rs 500/- per work/ per bid (Non-Refundable) by way of Demand Draft/ Pay Order favoring Union Bank of India payable at Pune. 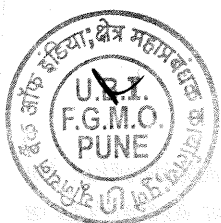

2. TENDER NOTICE

2.1. **Scope of work:** Union bank of India, Zonal Office Pune invites sealed applications for Empanelment of Architects, Structural Engineers and Contractors for Furnishing work (including civil repairs including new work, structural rehabilitation of building, furniture, sanitary and plumbing, waterproofing), Electrical work including repairs, earthing, ATM grouting, Air conditioning (installation, servicing & maintenance). The bids will be assessed on prequalification criteria and other terms and conditions mentioned in this document. Qualified bidders will be empaneled under Pune Zone for 3 years duration and will be used for carrying out different works in branches/ATMs/Offices under Pune Zone. The requirement of work will be assessed by the bank and bank may appoint Architect/Structural Engineers to undertake the project/work. The selected vendor must work under the assigned Architect to complete the assigned task/work.

2.2. Sealed Applications are invited by:

2.3. The contractors, architects & structural engineers shall be empaneled for Pune Zone for duration of 3 years from the date of completion of process and will be informed through empanelment letter from the bank.

2.4. The Empaneled vendors will be participating in Tenders/quotations for works as and when required by the bank. Closed tenders will be asked from vendors through publication of Tenders on Bank's website or by asking quotations for which the decision of Bank will be final. In case the empaneled vendors do not participate in 3 successive tender processes, their empanelment with the bank may be summarily rejected.

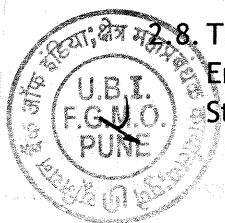
2.5. Merely participating in Empanelment process or getting empaneled under Pune Zone does not qualify the vendor to claim work. All rights in this regard will be on the discretion of the bank.

2.6. The Firms are required to complete the form of application as per format given in this document and sign each page of application before submission. Supporting documents in respect of all points mentioned in application form should be submitted in technical bid. The complete set is to be enclosed in a sealed envelope addressed to:

2.7. The Tenders will be received up to 03:00 PM on 23.01.2024.

2.8. The Tender is to be submitted in a sealed Envelopes super scribing with 'Application for Empanelment of Contractor for Furnishing or Electrical or Air-Conditioning or Architects or Structural Engineers (strike out whichever is not applicable) for Branches/ ATMs/ Offices of



Union Bank of India in Regional Office Pune Metro & Regional Office Greater Pune under Pune Zone'.

2.9. Tender document should contain complete application form with all the relevant information (Bio-data, General conditions, warranty clause, detailed terms & conditions, feedback forms and copy of work orders in support of experience, duly signed on each page along with cost of the Tender Document). No information regarding price is to be given in Technical bid.

2.10. Tenders without Tender fee, Pay Order/ Demand Draft shall be summarily rejected. In case of bidders are MSIC/MSME registered with NSIC, they are eligible for waiver of Tender document cost. However, they need to provide valid NSIC Certificate clearly mentioning that they are registered with NSIC under single point registration scheme. For claiming relaxation under NSIC category, bidders must produce original NSIC registration certificate at the time of opening of Technical bids.

2.11. No Tender will be received after the expiry of the time & date notified for receiving tenders, under any circumstances whatsoever.

2.12. The Tender will be opened at 03:30 PM on 23.01.2024 at above address in the presence of authorized representative of contracting agency. No separate intimation/ correspondence will be sent in this regard.

2.13. The Tender shall remain valid for acceptance for a period of 180 days from the notified last date of Tender submission.

2.14. The Bank reserves the right to accept / reject the lower or any or all tender received without assigning any reasons thereof.

2.15. Bank reserves all the right to shortlist the vendors based on their feedback from Clients of bidder, quality, quantity, period in business, infrastructure, supervision, locations, business, after sales etc. The Bank reserves the right to empanel/shortlist top rated/scoring one or more vendors at Banks' discretion. At any point of time if the services of the vendor are found unsatisfactory, Bank reserves all rights to depanel the contractor. No request in this regard will be entertained under any circumstances.

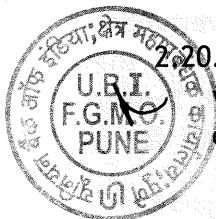
2.16. All Tenders in which any of the prescribed conditions are not fulfilled or incomplete in any respect are liable to be rejected.

2.17. This Tender Notice/RFP shall form part of the contract documents.

2.18. Selection of contractors will be based on the ability and competence required for good quality jobs to be performed by them.

2.19. If the space provided in the Performa is insufficient for giving full details, the same may be given on a separate sheet of paper. All columns must mandatorily be filled by the agency seeking empanelment.

2.20. Decision of the Union Bank of India regarding selection of contractors for empanelment will be final and binding and no further correspondence will be entertained. Contractors empaneled will be informed by post/email.



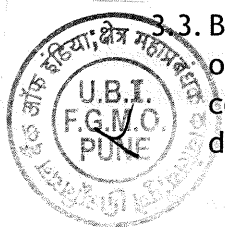
- 2.21. Intending contractors are requested to read carefully before filling the particulars in the Performa.
- 2.22. Information / details furnished by selected party, if found to be false at any time in future or any information affecting empanelment is willingly / unwillingly withheld, if come to the notice of the Bank at any point of time, the bidder's empanelment can be cancelled immediately.
- 2.23. Wherever copies are required to be furnished, these should be self-certified copies.
- 2.24. Application form is non-transferable.
- 2.25. Bank at its own discretion may award AMC of selected equipment's (air-conditioning etc.) to empaneled vendors by asking sealed quotations.
- 2.26. Bank does not compromise on quality of products and expect good quality product and material to be used by the contractor. If any adverse feedback is received by bank, Bank reserves all rights to depanel the vendor from Empaneled list of Pune Zone. All products supplied to bank should be supplied under warranty clause and the contractor will be liable for any defects arising in Warranty period at own cost.
- 2.27. Years means financial year unless stated otherwise.
- 2.28. **Bids/RFP which are not in sealed covers will not be accepted.**
- 2.29. Bidders with unsatisfactory feedback from reference sites or documents/ facts not found in order on verification as per stipulated criteria or Labor Acts/Rules applicable will not be considered for empanelment.

3. ELIGIBILITY CRITERIA FOR SHORT-LISTING:

For Empanelment of contractors, architects and structural engineers, following criteria shall be applied. For this purpose, Applicants shall submit proof of documents along with the Tender. Vendors not submitting proof documents and/or not conforming to any of these parameters will not qualify for empanelment.

GENERAL CRITERIA & DOCUMENTS TO BE SUBMITTED

- 3.1. Bidder applying for empanelment should be either registered companies or registered partnership firms or Registered Proprietorship firm. (Proof to be attached).
- 3.2. Bidder should be in the business (for the work applied for) for not less than 5 years. Working experience of individual/ proprietor as an employee with other firm shall not be considered valid for counting of total work experience. Working experience will be counted in the particular work for which empanelment is sought. Working experience in another work will not be considered valid for counting of total work experience. Work experience will be calculated on the basis of registration certificate submitted as per para 3.1.
- 3.3. Bidder should be empaneled and providing services to at least two PSU banks/Government organizations/PSUs for at least 3 years. Empanelment letter & Work order for the concerned work (for which empanelment is sought) should be submitted along with Tender document for verification of the same. If empanelment letter is not available for a



particular organization, 2 work orders (for work order more than 2 lacs each) for each year for 3 consecutive years from same organization will be considered as the bidder was empaneled with that organization.

3.4. Bank will seek confidential feedback from clients of vendor and thus bidders are required to furnish complete details of clients as per Annexure 4 and Annexure 5. Poor feedback/rating by clients will be considered as unsatisfactory and the bidders will not be considered for empanelment. Bank will obtain confidential feedback from at least 4 reference sites as quoted by bidder in annexure 4. Out of four reference site details, the bidders should quote at least 2 reference sites of PSU banks/Govt organizations of Maharashtra State. Bank will obtain a Quantitative confidential feedback from the clients and may disqualify bidders, if unsatisfactory feedback is received from any client. If no feedback is received within 15 working days and even after reminder, it will be presumed that the work of bidder is unsatisfactory and the application of concerned bidder for empanelment shall be summarily rejected. Thus, bidder is required to submit at least four reference site details as per Annexure 4 of the tender document.

3.5. Bidder should mandatorily have Income Tax PAN, TIN No, GST registration. (Attested copies of Pan Card, TIN No, GST certificate and latest Income tax return to be submitted).

3.6. Bidder should have Registration under Shops & Establishments Act under Maharashtra. (Self-Attested copy of certificate to be submitted).

3.7. The bidder should have at least one of its operational registered office at Pune. (Submit valid proof of office address (telephone bill/registered rent agreement/ownership document on the name of firm only)).

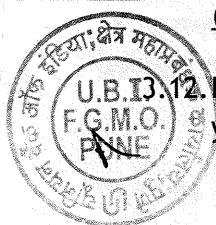
3.8. Bidders shall not be owned or controlled by any director or officer/employee of the bank or their relatives having the same meaning as assigned under section 6 of the Companies Act 1956. (A certificate denying the ownership of Agency/Firm/Manufacturer/ Dealer by any director or officer/employee of the bank or their relatives having the same meaning as assigned under section 6 of the Companies Act 1956 issued by the CEO or Director of the Firm to be submitted along with the tender).

3.9. Bidders should submit an undertaking (on their letter head) that they have not been black listed by any of the Govt. Authority or PSUs/PSBs duly signed by authorized signatory with company seal. If at any later stage it comes to the notice of Bank that the firm is blacklisted by any of the Govt. Authority or PSUs/PSBs, the contract with the firm will be terminated.

3.10. Bidders should have registration number for payment of Goods and service tax (GST) and their GST return should have been filed till last quarter (copy of GST return of past one year to be enclosed). Firms having invalid GST number or cancelled GST number, or inactive GST number will be rejected. (Copy of GST registration is to be submitted)

3.11. Bidder should have made net operating profit for past three years during five years (attach audited Balance sheet of last 3 years). In case the firm is not under audit then they should submit ITRs along with computation sheets certified by CA & Proof of Payment of Tax. (Copy of Challan etc.)

For empanelment of Architects and Structural Engineers, minimum experience required is 5 years in execution of similar kind of works in PSU Banks/Government offices/PSUs.



3.13. The Architects should be member of Institute of Architects/Council of Architects/Institution of Engineers or any other professional institute (submit proof). Also, Structural Engineer should be member of Institute of Engineers and should have valid Structural License Certificate issued by Appropriate/Competent Authority for carrying out its related work.

3.14. In partnership architect firms or structural engineer firms, all the partners should be qualified Architects only or qualified Structural Engineer only (submit proof).

3.15. **CRITERIA FOR PREQUALIFICATION:**

3.15.1. Bidders will self-assess themselves as per Para 18 B of Annexure 1 (for contractors), as per Para 17 of Annexure 2 (for Architects) and as per Para 17 of Annexure 3 (for Structural Engineer) of this document. Supporting documents in respect for each point of Pre-qualification table should be submitted along with Tender document. 60% of the self-assessed prequalification marks of the bidders will be considered for evaluation.

3.15.2. Confidential Feedback points out of total 40 marks will be added into prequalification marks as mentioned in Annexure 1 and 2 and final marks will be assessed for evaluation. Total 60% marks of prequalification criteria will be added into quantitative average feedback of the bidder and the final marks out of 100 will be assessed for minimum qualifying marks. Final qualifying marks should be more than 80 for considering application for empanelment. Firms, scoring more than 80 points after weighted average, will only be considered for Technical evaluation. Criteria mentioned above are just minimum requirement. The Bank at its discretion may upgrade/downgrade the criteria. No complaint on this account will be entertained under any circumstances. Please check example mentioned below.

For example, if any firm scores 90 marks out of 100 in prequalification criteria and scored 25 marks out of 40 in confidential feedback report. The total marks for consideration will be-

Prequalification marks - $90 * 60\% = 54$

Confidential feedback - 25

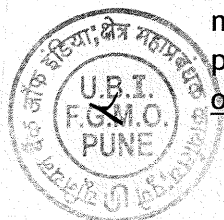
Total marks for consideration - $54+25 = 79$

79 marks is below 80 and thus the particular bid/application will be rejected

3.15.3. Self-assessed score submitted by the bidders will be modified/revised as per the document submitted by the bidder by the Technical Evaluation Committee after due Scrutiny/evaluation of the documents.

3.16. **SOLVENCY CERTIFICATE:** The bidder applying for Furnishing, Electrical and Air Conditioning tenders should enclose Solvency Certificate of requisite amount as mentioned in point no.18(B) at Sr.No.3 in the biodata format of Contractors. The solvency certificate should not be older than six months from the date of submission of the tender. If Solvency certificate is not submitted, marks for solvency certificate as assigned in Prequalification criteria will be awarded zero.

4. The bid shall contain no erasures or over writing except as necessary to correct errors made by the bidder, in which case such corrections shall be authorized by the person or persons signing the bid. Complete bid along with all the required proofs should be handed over in sealed cover, as mentioned to:

5. Technical Offer (TO):

5.1. Tender fee of ₹.500/- (DD/pay order), proof of document for exemption, if eligible for exemption as per NSIC registration.

5.2. Biodata of the contractors should be submitted as per Annexure-1

5.3. Biodata of the architects should be submitted as per Annexure-2

5.4. Biodata of the structural engineers should be submitted as per Annexure-3

5.5. Details of the Work completed as per Annexure-4

5.6. Reference-Site details as per Annexure-5

5.7. Letter of Undertaking Declaration as per Annexure-6

5.8. Letter of Undertaking for blacklisting as per Annexure-7

5.9. Documentary proof supporting the eligibility criteria and annexure must be submitted (wherever applicable)

5.10. The Technical offer must be submitted in an organized, numbered (on each page) and structured manner (spiral binding will be appreciated). Each page should be signed and stamped by the authorized official. No brochures/leaflets etc. should be submitted in loose form.

5.11. **Bank reserves the right to reject an offer under any of the following circumstances:**

5.11.1. Document/RFP cost Rs.500/- per category is not submitted (NSIC bidders may be exempted subject to furnished attached documents).

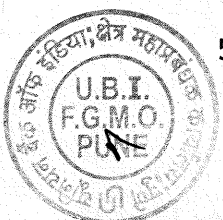
5.11.2. Offer is incomplete and/or not accompanied by all stipulated documents (with attestation wherever required)

5.11.3. Offer is not in conformity with the terms and conditions stipulated in this document.

5.11.4. Specifications stipulated in RFP are not met with. However, deviations resulting in higher/superior configuration will be accepted.

5.11.5. Or if found that the information provided in the offer is bogus/false.

5.11.6. Declarations as per Annexure 5 is not submitted.



- 5.11.7. Declaration that the Firm is not blacklisted by any Govt. Authority or PSUs/PSBs duly signed by authorized signatory with company seal as per Annexure 7 is not submitted.
- 5.11.8. Poor rating by empaneling agencies (Clients of bidder) even if one client gives poor rating the bidder may be not considered.
- 5.11.9. If the firm scores less than 80 marks in weighted average.
- 5.11.10. Unsatisfactory feedback is received from any Client.
- 5.11.11. Self-attested Photocopies of relevant documents / certificates as proof in support of various information submitted in aforesaid annexure and other claims made by the vendor. If the number of vendors qualifying the eligibility criteria of bank as per this document is less than 5, bank reserves all rights to relax the eligibility conditions.

6. EVALUATION PROCESS

Offers (Tenders) will be evaluated in the following stages:

6.1. Stage I

Opening of bids by Tender Opening Committee as per date mentioned in this document in front of Bidders/Representatives of bidders.

6.2. Stage II

Incomplete Offers, i.e., offers not accompanied with Tender cost shall be rejected.

6.3. Stage III

6.3.1 Bidders will self-assess themselves as per Para 18 B of Annexure 1 (for contractors) and as per Para 17 of Annexure 2, 60% of the self-assessed prequalification marks of the bidders will be considered for evaluation.

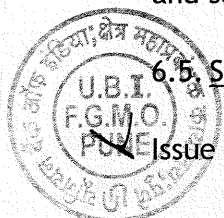
6.3.2 Confidential Feedback points out of total 40 marks will be added into prequalification marks as mentioned in Annexure 1 and 2 and final marks will be assessed for evaluation. Bank reserves all rights to obtain feedback from other clients of bidder. If unsatisfactory feedback is received for any bidder, the bid shall be summarily rejected.
